Having received a written request, a copy of which is attached hereto, by e-mail on December 29, 2016, and further updated, from Attorney James G. Thank you for contacting individuals to serve as public members to the McHenry Township Officers Electoral Board for hearing on objects filed.

After my initial letter, and our telephone conversation today, I received notification from the McHenry Township Supervisor that there are two (2) additional objections that require appointment. The objections was from Bob Anderson, against Candidate, Neal Schepler, Trustee Candidate, and Craig Wallace, Trustee Candidate, that were received at the same time (December 27, 2016 at 4:04 pm) as the other Bob Anderson objections.

**RE: McHenry Township Officers Electoral Board – Designation of Public Members**

Dear Judge Sullivan:

Following up my phone message from yesterday about McHenry Township, I am writing to identify all of the candidates and objectors and the total number of public members needed relative to each objection so that you may appoint public members.

Pursuant to 10 ILCS 5/10-9(4), "[t]he township officers electoral board to pass upon objections to the nominations of townships officers shall be composed of the township supervisor, the town clerk, and that eligible town trustee elected in the township who has the longest term of continuous service as town trustee, of whom the township supervisor shall be the chairman." Furthermore, it provides that "in the event that any member of the appropriate board is a candidate for the office with relation to which the objector's petition is filed, he shall not be eligible to serve on that board and shall not act as a member of the board and his place shall be filled as follows: c. In the Townships officers electoral board by the eligible elected town trustee who has had the second longest term of continuous service as town trustee."

There are 28 objections filed on 20 candidates, and we have attached a summary of those filed objections in relation to their filed date, showing date filed, time filed, objectors name, candidates name, and position, see Exhibit A. Exhibit B is a grouping of the filed objections with the 6 different electoral boards based on disqualification of members where the official was a candidate for an office involved in the objection, and they were replaced by the designated substitute. 
