

ADMINISTRATIVE ORDER NO 2007-14 22nd JUDICIAL CIRCUIT McHENRY COUNTY, ILLINOIS

It is ordered that all prior Administrative Orders establishing judicial assignments and court calls are hereby vacated and that this Administrative Order is effective on April 23, 2007.

IT IS HEREBY ORDERED that the following judicial assignments and court calls are established.

<u>CRIMINAL DIVISION:</u> (Judge Sharon L. Prather- Presiding Judge of the Criminal Division)

CRIMINAL FELONY I CALL (Judge Sharon L. Prather- Courtroom 304 (formerly Courtroom A320))

½ of Criminal Felony (CF) and Miscellaneous Remedy (Search Warrants, Rendition, Habeas Corpus (criminal), Eavesdropping, Extradition, Fugitives from Justice, Forfeitures, and Sexually Violent Person Commitment Act proceedings); Criminal Felony I Call #1 backup; Criminal Misdemeanor Jury Call #2 backup (divided evenly by Defendant Name between Criminal Felony I Call and Criminal Felony II Call), #6 back up for Civil I Call and Civil II Call, and #3 back up for Criminal Misdemeanor Combined Jury/Bench Call.

CRIMINAL MISDEMEANOR JURY CALL (Judge Charles P. Weech- Courtroom 301 (formerly Courtroom A380))

Criminal Misdemeanors (CM); Driving under the influence (DT); Traffic Violation (TR); Conservation Violation (CV); Ordinance Violation (OV); all of the aforementioned except for those matters assigned by case type and/or municipality or state and local law enforcement agency to Courtroom 303 (formerly A340)); Bond Court; Mental Health Court; #2 backup for both Criminal Felony I Call and Criminal Felony II Call; #2 backup for the Criminal Misdemeanor Combined Jury/Bench Call; #2 backup for the Criminal Misdemeanor Call; #3 backup for the Traffic Call; #4 backup for Civil I Call and Civil II Call; #5 backup for Adoption (AD) and #4 backup for non-support matters only (FA) and (CM).

CRIMINAL MISDEMEANOR COMBINED JURY/BENCH CALL (Judge Gordon E. Graham- Courtroom 303 (formerly Courtroom A340))

All Bench and Jury Trials, Summary Suspension Hearings, Judicial Driving Permit Proceedings, Forfeitures arising out of CM or DT cases assigned to this courtroom, Petitions to Revoke Proceedings and Bond Hearings in cases initiated by the following municipalities and/or state or local law enforcement agencies:

#3 backup for Criminal Misdemeanor Jury Call; #1 backup for Mental Health Court and #2 backup for Bond Court.

CRIMINAL MISDEMEANOR CALL (Judge Robert K. Beaderstadt - Courtroom 101 (formerly Courtroom A180))

Criminal Misdemeanor (CM); Driving Under the Influence (DT); Traffic Violation (TR); Conservation Violation (CV); Miscellaneous Remedy (Forfeitures arising out of CM or DT cases)(MR); excepting all cases assigned to Courtroom 303 (formerly Courtroom A340); #1 backup for Traffic Call; and #3 backup for Bond Court.

TRAFFIC CALL (Judge Thomas A. Meyer - Courtroom 102 (formerly Courtroom A160))

Traffic Violation (TR); Conservation Violation (CV); Ordinance Violation (OV); #3 backup for Criminal Misdemeanor Call; and #4 backup for Bond Court.

SPECIAL ASSIGNMENT (Criminal/Civil/Family) (Judge Michael W. Feetterer - Courtroom 203)

CIVIL III CALL (Judge Michael J. Sullivan- Courtroom 358 (formerly Courtroom C330))

Probate (PR); Municipal Corporations (MC); Mental Health (MH); Tax (TX); #2 backup for Civil I Call and Civil II Call; #1 backup for Civil IV Call; #6 backup for Criminal Felony I Call and Criminal Felony II Call.

CIVIL IV CALL (Judge John D. Bolger - Courtroom 357 (formerly Courtroom C320))

FAMILY II CALL (Judge Suzanne C. Mangiamele- Courtroom 360 (formerly Courtroom C350))

1/3 of Dissolution or Divorce (DV) and Family (FA) (excluding non-support matters); Independent Orders of Protection (OP); #2 backup for Family I Call; #1 backup for Family III Call; #3 backup for Juvenile Court Call; #2 backup for non-support matters only (FA and CM cases); and #1 backup for Adoption.

FAMILY III CALL (Judge Robert A. Wilbrandt, Jr. - Courtroom 359 (formerly Courtroom C340))

1/3 of Dissolution or Divorce (DV) and Family (FA) (excluding non-support matters); All non-support matters only (FA and CM cases); #1 backup for Family I Call; #1 backup for Family II Call; #2 backup for Juvenile Court Call and #3 backup for Adoption.

JUVENILE COURT CALL (Judge Michael J. Chmiel- Courtroom 202)

Juvenile Abuse and Neglect (JA); Juvenile Delinquent (JD); Juvenile (JV); Adoption (AD); #3 backup for Family I Call, Family II Call and Family III Call; and #3 backup for non-support matters only (FA and CM cases).
