IT IS HEREBY ORDERED that effective October 1, 2010, Administrative Order 2007-04 is vacated; and, further, IT IS HEREBY ORDERED that the following Committees of the 22nd Judicial Circuit are established. The Chief Judge shall be an ex-officio member of each Committee and shall receive notice (and minutes if prepared) of all meetings. The chairperson of each Committee may, (1) request that the Chief Judge add judicial or non-judicial members to a committee on a permanent basis; (2) request that the Chief Judge add judicial or non-judicial members to a committee on a temporary basis to deal with particular questions or problems, and (3) appoint subcommittees.
