In any case in which a Defendant has a probation fee imposed under the provisions of 730 ILCS 5/5-6-3 and/or 730 ILCS 5/5-6-3.1 and, thereafter, the jurisdiction over the Defendant is transferred from the sentencing court to the court of another circuit with the concurrence of both courts, or the supervision of the Defendant is transferred by the Probation Department; and upon the filing with the clerk of the court of the Notification of Changes to the Probation Fee Schedule form (Exhibit A attached hereto), signed by both the Defendant and the Director of Court Services or his designee;

IT IS ORDERED that the Clerk of the Circuit Court of the 22ND Judicial Circuit, McHenry County, Illinois, is authorized to make adjustments to the amount of Probation Fees owed by the Defendant and/or refund overpayment of Probation Fees to the Defendant when directed by the Director of Court Services or his designee per the *Notification of Changes to the Probation Fee Schedule* form which has been filed in the Defendant's court file.
