Having received written requests, copies of which are attached hereto, by e-mail on December 13, 2016 and December 14, 2016, from Attorney James P. Kelly of the law firm of Matuszewich & Kelly, LLP, attorneys for Algonquin Township, requesting pursuant to 10 ILCS 5/10-9(4) that the Chief Judge appoint public members to the Algonquin Township Officers Electoral Board to consider objections to the nomination papers of candidates for the offices of Township Supervisor and Township Trustee, at the February 28, 2017 Primary Election, for the reason that members of the Electoral Board are disqualified from serving because of various conflicts and statutory disqualifications.


This Court having considered the request and having reviewed the statutory authority, 10 ILCS 5/10-9(4), finds that the appointment of public members of the Algonquin Township Electoral Board is appropriate and required.

THEREFORE, IT IS ORDERED that the following shall serve as public members of the Algonquin Township Electoral Board relative to the nomination petitions for candidates at the February 28, 2017 Primary Election, to consider objections as set forth as follows:

Dear Judge Sullivan:

Following up on our telephone conversation from earlier today concerning the Algonquin Township Electoral Board, I am writing to identify all of the candidates and objectors and the total number of public members needed relative to each objection so that you can appoint public members. As we discussed the Board will need an additional public member. However since our conversation it appears that both due to illness and disqualifications, we will need 2 additional public members of the electoral board. I would therefore request that a chairman and two additional public members be appointed for the following hearings. I would ask that Jeremy W. Shaw who was previously appointed as a public member be appointed as the chairman. The hearings are anticipated to be held on Monday, December 19, 2016, at 1:30 p.m. at the offices of Algonquin Township. I would therefore request that your Administrative Order No. 2016-09 be amended by appointing two additional public members to the electoral board and appointing one of the members as the chairman.




