WHEREAS, on October 24, 2023, Administrative Order No. 2023-19 was entered to address assignments of judicial personnel and courtrooms in consideration of the appointment of a new judge and the looming retirement of another;

WHEREAS, the *Special Assignment and Initial Appearance Court Call* in the Problem-Solving Court Division needs to be divided to leverage the experience of Judge Jennifer L. Johnson in backing up the other calls in that Division to the extent possible;

THEREFORE, IT IS ORDERED that this Administrative Order shall take effect on and after December 1, 2023, such that Administrative Order No. 2023-19 is modified insofar as the following assignments shall be made:

Criminal Misdemeanors (CM); Driving Under the Influence (DT); Major Traffic (MT); Traffic Violation (TR); Conservation Violation (CV); Ordinance Violation (OV); Quasi-Criminal (QC); all jury demand cases initiated by the following state, municipal, and/or or local law enforcement agency:

Initial return date on all Misdemeanor (CM) (DT) (MT) (CV) matters from all municipalities and/or State or local law enforcement agencies; all Bench Trials, Petitions to Revoke Proceedings, Bond Hearings, Summary Suspension Hearings, and Forfeitures arising out of CM, MT or DT cases when the underlying case is not transferred to a jury courtroom.

(IN THE PROBLEM-SOLVING COURT DIVISION:)

SPECIAL ASSIGNMENT CALL (Judge Jennifer L. Johnson – Courtroom 104)

Coverage and back-up for Problem-Solving Court Division Cases.

INITIAL APPEARANCE COURT CALL (Judge Michael J. Chmiel - Courtroom 103)

Initial Appearance Court ("IAC"), with responsibility for IAC under the Pretrial Fairness Act during regular Court hours; Out-of-County ("OCW") Supervising Judge, with responsibility for criminal warrants issued outside the Circuit and served and processed in this Circuit.
