WHEREAS, Circuit Judge Michael J. Chmiel began his term as Chief Judge on December 1, 2022, inventoried desires and needs of the Circuit, and believes eight committees will help the Circuit best address its duties and obligations; *and therefore*

IT IS ORDERED that:


- (A) Administrative Order 2022-02 (on the Committees of the Circuit) is vacated.
- (B) The Chief Judge shall be an *ex-officio* member of each Committee and shall receive notice (and minutes, if prepared) of all meetings, and that the Assistant to the Chief Judge shall facilitate arrangements for meetings of the Committees upon request of the Chair of a Committee.
- (C) The Chair (or Vice Chair in the absence of the Chair) of each Committee shall call meetings and address issues as needed and may (1) request that the Chief Judge add judicial or non-judicial members to a Committee on a permanent basis; (2) request that the Chief Judge add judicial or non-judicial members to a Committee on a temporary basis to deal with particular questions or issues; and (3) appoint subcommittees.
- (D) Each Committee shall meet periodically and/or as needed to address the needs of the Circuit and should meet at least twice each calendar year.
- (E) *Ad Hoc* Committees may also be appointed by the Chief Judge as needed to help meet the needs of the Circuit.

IT IS FURTHER ORDERED that the Committees of the Circuit shall be as follows:
