ADMINISTRATIVE ORDER NO. 2025-04 22nd Judicial Circuit McHenry County, Illinois

(Committee Assignments)

WHEREAS, the personnel of the Circuit continues to change and membership on the Committees of the Circuit needs to be updated;

NOW, THEREFORE, IT IS ORDERED that:

- (A) Administrative Order 2024-22 is vacated.
- (B) The Chief Judge shall be an *ex-officio* member of each Committee and shall receive notice (and minutes, if prepared) of all meetings, and that the Executive Assistant to the Chief Judge shall facilitate arrangements for meetings of the Committees upon request of the Chair (or Vice Chair in the absence of the Chair) of a Committee.
- (C) The Chair (or Vice Chair in the absence of the Chair) of each Committee shall call meetings and address issues as needed and may (1) request that the Chief Judge add judicial or non-judicial members to a Committee on a permanent basis; (2) request that the Chief Judge add judicial or non-judicial members to a Committee on a temporary basis to deal with particular questions or issues; and (3) appoint subcommittees.
- (D) Each Committee shall meet periodically and/or as needed to address the needs of the Circuit and should meet at least twice each calendar year.
- (E) Ad Hoc Committees may also be appointed by the Chief Judge as needed to help meet the needs of the Circuit.
