

PROBLEM SOLVING COURTS:
GENERAL SCHEDULE



WHEREAS the Problem Solving Court Division of the 22nd Judicial Circuit is comprised of Problem-Solving Courts, Juvenile Court, and Special Assignment;

WHEREAS the Problem Solving Courts include Mental Health Court, DUI Court, and Drug Court;

WHEREAS Administrative Order 2025-14 assigns Problem Solving Courts to Courtroom 104 effective December 1, 2025;

WHEREAS Problem Solving Court matters are Staffed before each court appearance consistent with Illinois Problem Solving Court Standards;

WHEREAS the Court wishes to communicate the usual and customary schedule to be followed in Problem Solving Courts effective December 1, 2025;

NOW THEREFORE, IT IS ORDERED:

Effective December 1, 2025, and continuing thereafter until further Order,

1. Court appearances for Problem Solving Courts will be held in Courtroom 104.
2. Staffing will be held in Room 206, within the secure hallway on the 2nd Floor of the Michael J. Sullivan Judicial Center. Access to the Staffing Room shall be controlled by court security and/or court personnel through a secure doorway marked "authorized personnel only" located within the rotunda area on the 2nd Floor of the Judicial Center. Questions about entry through the secure doorway may be directed to: Court Administration at (815) 334-4000 or the Office of Special Projects at (815) 334-4502.
3. Attorneys and other team members may, from time to time, attend Staffing remotely. A link to access Staffing remotely is provided with staffing reports the day prior to a scheduled court appearance.

4. The schedule for Staffing and for Court Appearances in the Problem Solving Courts is as follows:

Monday	Specially set matters, including, but not limited to, Acceptance into a Problem Solving Court.
Tuesday – Mental Health Court	9:00 a.m. – Staffing with Public Defender 11:00 a.m. – Staffing with Private Attorneys 1:30 p.m. – Mental Health Court in CR104
Wednesday – DUI Court	9:00 a.m. – Staffing with Public Defender 10:00 a.m. – Staffing with Private Attorneys 1:30 p.m. – DUI Court in CR104
Thursday – Drug Court	9:00 a.m. – Staffing with Public Defender 11:00 a.m. – Staffing with Private Attorneys 1:30 p.m. – Drug Court in CR104
Friday	Specially set matters

5. Acceptance into Problem Solving Courts is a formal process that occurs on the record and in the courtroom consistent with Illinois Problem Solving Court Standards. To maximize contact between a new Participant and the Problem Solving Court team, there is a strong preference to conduct Acceptances on Mondays or as early in the week as practicable. Attorneys and Participants are required to review and sign Acceptance documents prior to the Acceptance Court Appearance. These documents are available in Courtroom 104 and on the 22nd Circuit website.

6. Specially set matters include, but are not limited to, Acceptances, Sanctions Hearings, Dismissal Hearings.
