## **22<sup>nd</sup> Second Judicial Circuit Accepting Applications for McHenry County Public Defender**

**Woodstock, IL** - The 22nd Judicial Circuit Court of McHenry County is now accepting applications for the position of Public Defender for McHenry County. The application period is currently open and will close on December 31, 2025. Applicants must be attorneys licensed to practice law in the State of Illinois and be in good standing. Interviews will be held in January 2026, with specific dates to be released later. The 22nd Judicial Circuit is seeking applicants who demonstrate a strong commitment to public service, professionalism, and excellence in criminal defense practice. The appointment is scheduled to begin on February 9, 2026.
